Extinguishing media

Handling**

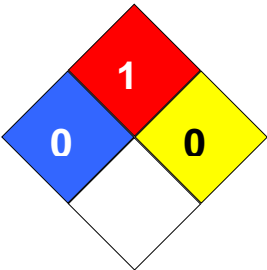
