Barge/Coasters	SELLER chartered CPT/CIP/DAP	<ul> <li>Lead-time requirement of minimum 15 (fifteen) working days from order acknowledgement until date of loading, excluding delivery time.</li> <li>Product cancellations of barge after the firm nomination may result in dead freight charges.</li> </ul>
	BUYER chartered FCA	- Lead-time requirement of minimum 15 (fifteen) working days from order acknowledgement until date of loading, excluding delivery time.  - BUYER to provide vessel nomination minimum 5 (five) working days prior to the loading date.  - Vessel acceptance by SELLER is subject to approval by SELLER's vetting organization.  - BUYER to adhere to instructions for FCA at the designated loading terminal.

Remarks: 1. Lead times are best estimates only and shall not be of essence. Lead times shall always be subject to product availability and acceptance of the order by Seller.

- 2. "Lead Time" is defined as the time from receipt of BUYER's order to BUYER's requested shipment date.
- 3. The day the order is placed is Day 1 of Lead Time calculation.
- 4. Transit time must be added to all Lead Times.
- 5. Order changes or cancellations can result in an administrative fee of 350 EUR per order change/cancellation and any additional costs directly resulting from this order change/cancellation can be charged to the customer (e.g. no show fee, wasted trip, detention costs, transporter cancellation fee, etc.).
- 6. The transportation, storage and handling of the product may give rise to additional costs as set out in this policy. Buyer shall have a period of five (5) business days after receipt of notice by Seller of the additional costs to object to these costs in writing, detailing the dispute. If Buyer does not respond within this 5-day period, Buyer shall be deemed to have accepted these additional costs in their entirety. Buyer shall ensure that Seller in any case receives payment of no less than the undisputed portion of such invoice by the due date.
