Based on the most recent update to the EU REACH Candidate List of Substances of Very High Concern (SVHC) published on 04 February 2026, the status of substances in specific Marlex® Polyethylene products as relates to EU REACH regulation 1907/2006/EC regarding Substances of Very High Concern (SVHC), remains unchanged. Each Marlex® Polyethylene product SVHC status is detailed in their respective Product Regulatory Overview (PRO) document, which can be accessed via the link provided below. Regarding the 2 June 2025 Annex XVII amendment for Regulation (EC) No 1907/2006, which includes restrictions on N,N-dimethylacetamide (DMAC; CAS RN 127-19-5) and 1-ethylpyrrolidin-2-one (NEP; CAS RN 2687-91-4), and the October 17, 2025 amendment on polycyclic aromatic hydrocarbons (PAHs), these substances are not intentionally used in the formulation of Marlex® Polyethylene products.
